- 1. Readable / Clear photocopy (all pages) of Transfer of Certificate Title (TCT) or Condominium Certificate of Title (CCT)
- 2. Photocopy of Mother Title with House Rules and Master Deed of Restriction (for condominium)
- 3. Location plan with vicinity map, duly prepared and Certified by a Geodetic Engineer or Licensed Surveyor
- 4. Photocopy (back to back) of Latest Tax Declaration on Land and Improvement
- 5. Photocopy of Real Estate Tax Receipt of the current year

6. Original copy of Tax Clearance of Certificate of non-deliquency in payment of realty tax for the current year.

## ADDITIONAL REQUIREMENTS

- 1. If Refinancing:
  - Latest Statement of Account from present mortgagee
- Official Receipts of payments of amortization for the past six (6) months
- 2. Contract to Sell / Deed of Absolute Sale
- 3. Notarized Lease Contract and Schedule of Tenants
- 4. Photocopy of Marriage Contract
- 5. Photocopy of two (2) valid IDs: TIN ID, Driver's License, PRC License, etc.
